Error in YTL50 for data between 197910 to 198602: YTL50 now consistently reports if the respondent's income is above or below median, as specified in the codebook; some earlier vintages of the database YTL50 erroneously reported income quintiles, which are separately reported in YTL5. 4. A small number of historical values of PX1Q2 and PX5Q2 from between between 202404 and 202511 have been revised to correctly reflect internal editing, topcoding, and bottomcoding. 10/27/2023	Aggregate estimates	<p>There was a minor technical error in the generation of the weights used to compute aggregate estimates between November 2022 and September 2023. We have since corrected the weights. The revised estimates in the October 2023 final release databook, along with all charts and tables that appear in the summary report, our main site (www.sca.isr.umich.edu), our data site (data.sca.isr.umich.edu), and our microdata repository (sda.umsurvey.org) reflect these revisions. Overall, the differences between the estimates originally released and the revised estimates are almost negligible, as seen in the comparisons below.
